In 2013, one of our volunteers came back from the Uganda Project outwardly changed and inspired by her experience. She told us, 'it doesn't matter what circumstance we have been born into. What matters is what we do with it. We cannot feel guilt of being born somewhere, but we can feel guilty of taking more from this earth than we give back.'

These words remind me of the original ethos by which I established the Foundation in 2005 alongside my own legal firm. ### Structure

The Foundation was established in 2005 as a trust (ABN 63 425 376 446). Kain C&C Charities Pty Limited (ACN 115 024 309) is the trustee of the Foundation. The Foundation is a public ancillary fund and has been endorsed by the Australian Taxation Office as a deductible gift recipient. All donations to the Foundation are tax deductible.

### Board

Kain C+C Lawyers Pty Limited (ACN 137 053 395) is the sole shareholder of Kain C&C Charities Pty Limited and has appointed a board of directors in accordance with the Foundation's governance policies and the Australian Taxation Office's requirements for public ancillary funds. Sitting underneath the Board are resources provided by Kain C+C Lawyers and other Corporate Partners to support the operations of the Foundation.

# 10 YEARS OF HIGHLIGHTS

2005

The Foundation was established.

2006

The Foundation forms a relationship with Hutt Street Centre by supplying and serving breakfasts and lunches as part of Hutt Street Centre's 'Angel for a Day' program.

2007

The Foundation in conjunction with Hutt Street Centre and Welfare Rights Centre, initiates a weekly Homeless Legal Clinic. Its scope is expanded to also include one-on-one computer literacy training sessions through the CREATE Space education program.

2008

The Foundation expands its horizons to supporting overseas projects with the official launch of the Uganda Project.

2009

The first Uganda Project is held in August of 2009 with 7 South Australian business people. The team assists in the construction of a house for 8 children and a house mother in Kampala, Uganda.

## 2013

Two Hands Wines holds their first Next Steps program at their winery in the Barossa Valley. \$52,000 worth of free legal advice and 74 hours of computer literacy training is provided to Hutt Street Centre clients. The 2013 Uganda Project team funds and assists in the construction of a house for 8 children and a house mother in Gulu, Uganda.

## 2012

The 2012 Uganda Project team funds and assists in the construction of a student dormitory in Suubi Village, Uganda. \$94,000 worth of free legal advice and 111 hours of computer literacy training is provided to Hutt Street Centre clients.

## 2011

The 2011 Uganda Project team funds and assists in the construction of a school ablutions block in Suubi Village, Uganda. 161 homeless persons receive \$167,000 worth of free legal advice, and 44 hours of computer literacy training is provided to Hutt Street Centre clients.

## 2014

The Busabala (UACO) Hospital facility officially opens in Kampala and over the course of the year provides 85 operations to women during childbirth. The 2014 Uganda Project team funds and assists in the construction of a student dormitory for orphans in Gulu. Two Hands Wines and Kain C+C Lawyers run Work Inspirations (previously Next Steps). The Foundation partners with Habitat for Humanity to build their first house for low income families in Davoren Park, South Australia.

## 2010

The Foundation enters into a 3 year memorandum with The Smith Family with a commitment to support annual career workshops and tertiary scholarships for disadvantaged students. The Foundation partners with Uganda Australia Christian Outreach (UACO) to help complete the build of Busabala (UACO) hospital facility in Kampala, Uganda.

## 2015

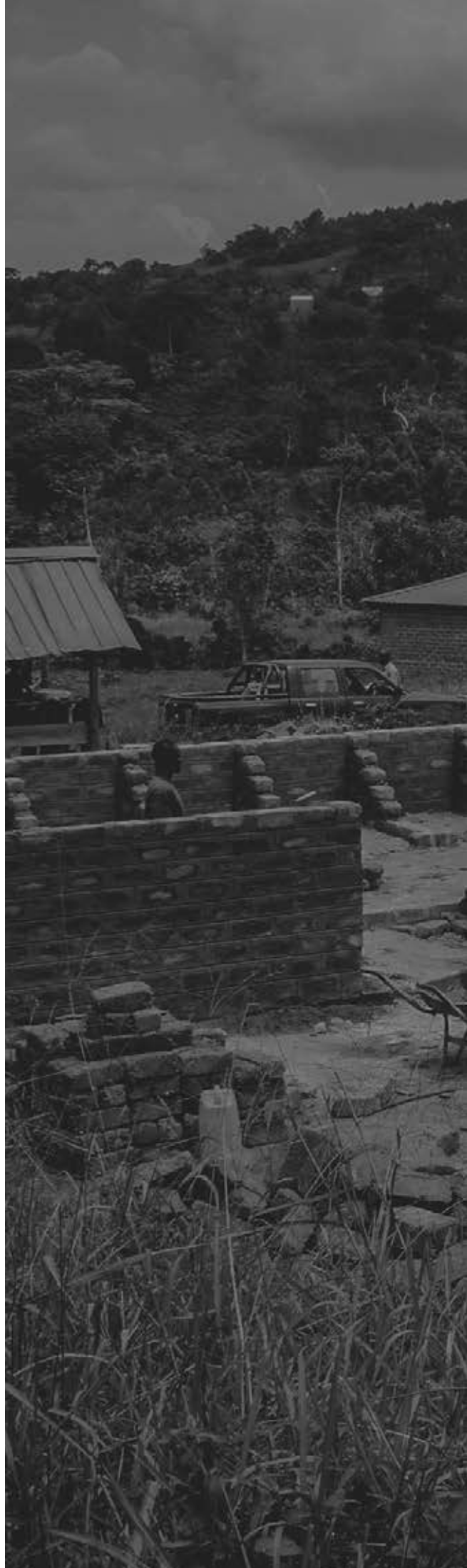
The Foundation is now partnered with 6 Australian corporate businesses and distributes close to \$150,000 per year to support children and youth. The Foundation plans their strategy for the next 5 years that includes educational and economic opportunities for children and youth to fulfill their potential.

## CORPORATE PARTNER FUNDING MODEL

---

The Foundation began as a funnel via which employees of Corporate Partners could make financial contributions to those less fortunate. It is now an established charitable entity and has evolved as a facilitator for Australian businesses to connect both financially and hands-on with children and youth focused community projects.

The Foundation's funding model sets it apart from other organisations with no time or overheads spent on direct fundraising. The Foundation utilises resources contributed by Corporate Partners to support the administration of the Foundation and directs 95% of funds direct to projects through Corporate Partner-driven funding schemes.

# YOUTH ENGAGEMENT

*For disadvantaged youth in South Australia, we provide opportunities for mentoring and connection.*



### Work Inspirations

**Y**oung people are experiencing higher levels of unemployment than any other age group, particularly those from disadvantaged backgrounds who are most at risk of long term marginalisation from the labour market. Work Inspirations (WI) is an Australia-wide, employer-led program that gives young people the opportunity for an inspiring introduction into the world of work. WI provides young people the opportunity to explore their passions and strengths, have informative career conversations, go behind the scenes of a workplace and hear from a variety of career professionals to gain insight into making a career 'happen'. The Foundation works alongside its Corporate Partner network and The Smith Family to deliver the Work Inspirations program for disadvantaged youth.

In FY15 ... The Foundation facilitated three Work Inspirations workshops. In September, Kain C+C Lawyers led the 2 day workshop with Freemont-Elizabeth City High School. The students heard from guest speakers who provided insights into their career journeys and were also treated with a backstage pass to Adelaide Oval to see the diverse operations and job opportunities behind stadium doors.

Two Hands Wines led the Craigmore High School Work Inspirations workshop in their winery facility in October. Students learnt about the variety of job pathways through interactive games and role plays as well as hearing from the Two Hands Wines staff about their varied job roles. In March of 2015, Kain C+C Lawyers ran their second Work Inspirations program which included a 'sports industry' twist. Students were given insight into five panellists who all had a love for sport but had ended up in diverse professions including CEOs of not-for-profit agencies, journalism and a franchisee owner.

### iTrack

**M**any young people today, particularly those from disadvantaged backgrounds, do not have the connections and networks to be inspired about their future. The iTrack program is an online mentoring program designed to connect, motivate, support and inform students who are beginning to formulate their post school plans. The Foundation works alongside its Corporate Partner network and The Smith Family to deliver the iTrack program for disadvantaged youth. Business volunteers are paired with students who seek mentors to provide career and life coaching. Team members commit one hour a week to mentor those who would otherwise have minimal to no career guidance.

In FY15 ... 3 people participated in the iTrack online mentoring program.

“ Thanks so much for the support and opportunities you provided for our students last week. I met with the students when they returned to school on both Thursday and Friday. They were walking taller; genuinely pleased they had attended the programme and eager to talk about their experiences. The students all felt that they had gained more confidence and purpose from the presentations and activities provided.

We really believe in the potential and innate abilities of our students. At school, we work hard to improve their literacy, numeracy and support them to complete year 12. However, what they often lack is knowledge about and experience in, a professional world of work. Programmes like the one you have just offered, provide students with the type of "cultural capital" they need, to back themselves in achieving their goals.

Our teachers also felt very welcomed and thought the activities were exactly what our students needed. They commented on the respect (rather than just patronage) shown by all of you, to our students. ”

# THE UGANDA PROJECT

*For some of the 2.5 million orphans in Uganda, we provide opportunities for housing and healthcare.*

The Uganda Project aims to alleviate problems faced by communities in a country that has been ravaged by HIV/AIDS, war and other diseases. The purpose of the project is to provide opportunities for housing and healthcare for some of the 2.5 million orphans and other communities in hardship in Uganda.

Since 2009, the Foundation has provided philanthropic funding to two community organisations in Uganda: Watoto Childcare Ministries, supporting the building of villages for orphans and Uganda Australia Christian Outreach (UACO) contributing towards the completion of a hospital theatre complex for women and children.

#### The Experience Trip

To inspire generosity and compassion in the corporate sector, the Foundation conducts an annual experience trip for our Corporate Partner network. The Foundation mobilises a team of employees to travel on a two week project visit to Uganda. The team is immersed in the social environment of the Foundation's work and is invited to experience and connect with communities. Travellers visit the five Community Partner projects and work hands-on building houses in the rural village of Gulu. Corporate Partners contribute a proportion of funds to support the project as well as providing their employees an exclusive experience at the heart of their own community work.

In FY15 ... 8 people from Kain C+C Lawyers, Two Hands Wines, KWP! Advertising and Blue Sky Alternative Investments took part in the Uganda Project trip as well as a student from Loreto College.

The team distributed over 200kgs worth of clothes, school materials and hygiene kits to orphans and children in need, donated a term's worth of porridge to 360 children in a rural village who frequently go without food, donated 12 desks to a school with minimal resources to enable 36 children a seat to learn and built a unit of a dormitory facility for a teacher in the rural town of Gulu to support education for orphans.

### Build a Home

In a suburb where unemployment is high and the median household income is 40% lower than the Australian average, families in the Edgcombe precinct in South Australia face significant challenges.

The Foundation works alongside its Corporate Partner network and Habitat for Humanity to support Habitat's Building Program. The Building Program helps unemployed youth into vocational training and work experience opportunities and low income families into a safe and secure home environment by providing financial and volunteer support. Business volunteers contribute hands-on towards the building of each home. By working with the Building Program, the Foundation aims to support existing target groups of other supported youth projects such as unemployed young adults and youth at risk.

In FY15 ... the Foundation provided funding and a combined 112 hours of hands on assistance towards the completion of two homes in Davoren Park, South Australia. 7 employees from Kain C+C Lawyers also gave a full day's work on the Brush with Kindness project where volunteers provide landscaping and minor repairs to the exteriors of homes of people living in poor housing.

### Welcome to Adelaide

In FY15, the Foundation worked alongside the Red Cross on their Social Inclusion program. Welcome to Adelaide, a series of tours provided to migrant communities new to Adelaide to assist them with navigating local community services and support. Volunteers from our Corporate Partner network hosted the tours alongside the Red Cross. Volunteers reported it was a unique opportunity to connect and contribute to the community while learning about new cultures. In January FY15, this program was unfortunately discontinued due to changes in government funding.

# FINANCIAL REPORT

Our Corporate Partners invest significant time and financial resources into the Foundation and it is the Board's view that it is extremely important that the Foundation directs these resources into helping those less fortunate in our community.

The Foundation is acutely aware of the great trust bestowed upon it by our Corporate Partners. To honour that trust the Foundation is committed to: ensuring that administration costs do not exceed an expense ratio of 5% of contributions received; and transparent disclosure of all administration costs incurred by the Foundation.

Through these commitments the Foundation ensures that the money contributed by its Partners is applied to its projects and not wasted on administration cost.

In FY15 just 4.3% of funds raised were spent on administration expenses (5% in FY14).

During the year the Foundation contributed \$39k to the building of a home for Ugandan orphans in Gulu, \$16k towards the completion of the UACO hospital infrastructure, \$10k to the Smith Family's Work Inspirations Program and \$7,500 to Habitat for Humanity to help fund the building of homes in Daveron Park in South Australia.

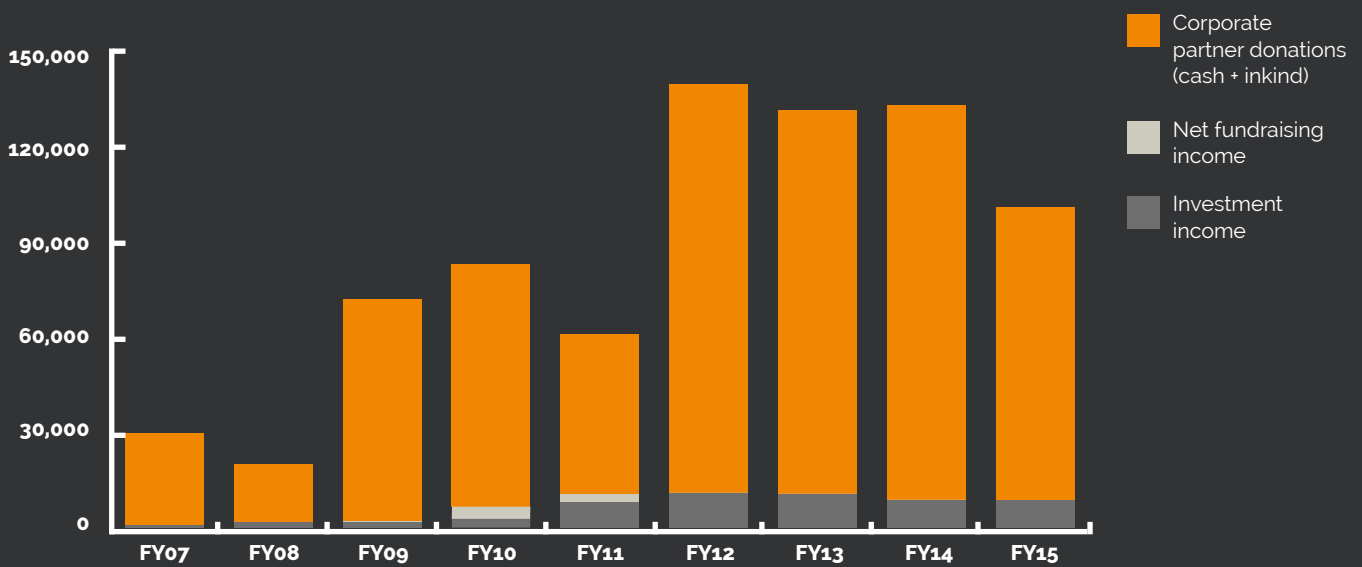
## Explanatory note to chart

The Foundation makes a difference to the lives of the disadvantaged both through financial contributions and providing hands on support. Without attempting to place a dollar value on the hands-on contributions made by our Corporate Partners, the non-financial contributions to the Foundation's projects, far outweighs the financial contribution.

The chart above shows where cash donations received have been directed. It should be noted that FY15 was lower than previous years due to the completion of two key Ugandan projects, funds have been retained to distribute into future projects which are currently undergoing feasibility. FY12 was also an unusually low year for money donated to projects. This was mainly due to a timing difference whereby \$45k of funding for the August 2013 Uganda Project was not paid until July 2012 where in previous years funding for the Uganda Project was required months in advance thus falling into the previous financial year.

**Where does the money come from?**

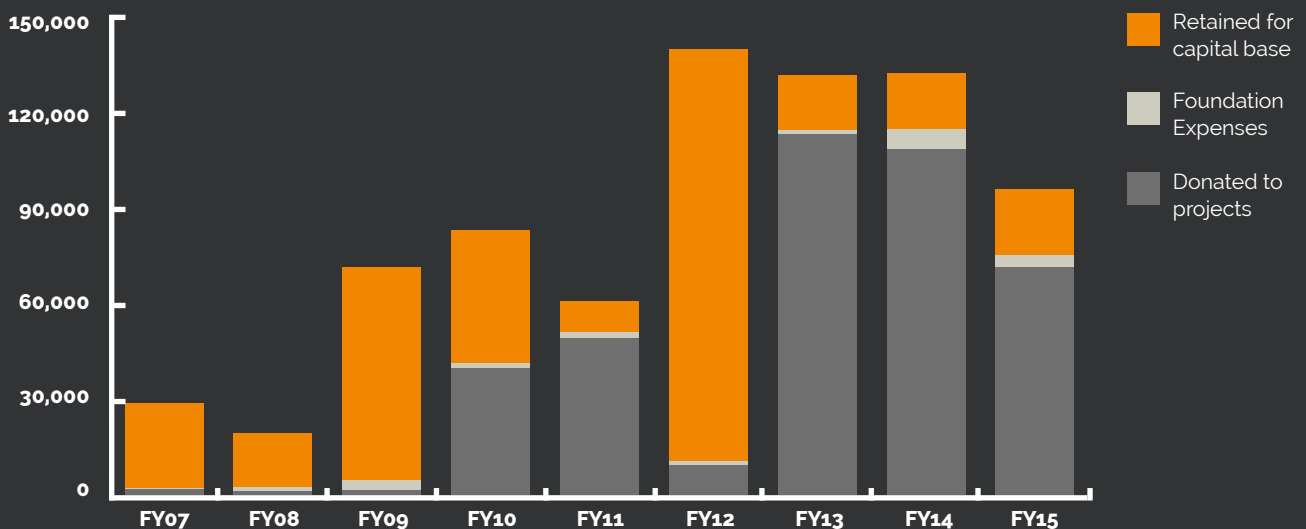
The Foundation's principle source of funding is donations from Corporate Partners (both cash and in-kind support). The chart below shows the sources of income from FY07 to FY15.



Note to chart: On 1 July 2011, the Foundation received a \$41,273 donation from Two Hands Wines attributable to the FY11 financial year (meaning that effectively FY11 donations shown in the chart are \$41K understated and FY12 donations are \$41K overstated). During FY13 and FY14 we supported the construction of the UACO hospital project in Kampala, Uganda with the support of third party contributions tied to that project. In FY15 we completed our commitments to the UACO hospital project. As a consequence, the tied contributions for that project ceased in FY15 giving rise to a 30% fall in income in FY15.

**Where does the money go?**

Funds raised are either directed into existing projects, retained in the Foundation or used to pay expenses.


